International Money Transfer is a cross border transaction in a specific currency.

Below is how to perform International transfer go to **Payment** then **Payment and** transfers then once off Payments.



Click International then fill the required field to transact





For International transfers IBAN number is the same as account number, for customers with IBAN number can fill the first field with IBAN number, the same will apply to those with account numbers.

- Beneficiary bank swift code can be searched from the swift code look up.
- The amount can be transferred now or at a later time/day to the beneficiary account
- With International transfer, the transaction allows attachments eg in voices.

In International transfers, all transaction in USD customer is advised to select FULL VALUE in corresponding charges. This means beneficiary will receive the exactly sent amount without deductions and the bank will settle its charges with sender.
